program CBP inspectors pre screen U S bound marine containers at foreign ports of loading The Customs Trade Partnership Against Terrorism C TPAT offers importers expedited processing of their cargo if they comply with CBP measures for securing their entire supply chain To raise port security standards Congress passed the Maritime Transportation Security Act of 2002 P L 107 295 in November 2002 The focus of debate in Congress has been about whether current efforts to improve port security are adequate in addressing the threat While many agree that Coast Guard and CBP programs to address the threat are sound they contend that these programs represent only a framework for building a maritime security regime and that significant gaps in security still remain
