

Vicarious Liability

Definition: Vicarious liability is where a third person/ party had legal responsibility for the unlawful actions of another.

Tortfeasor- Person who commits the tort and causes the harm and or damage (employee usually)

Claimant- Victim who suffers harm and or damage

Defendant- Person liable for the tort

Salmond Test:

Employers are vicariously liable when:

1. The employee has committed an unintentional tort;
2. The worker concerned has employee status, and;
3. The employee committed the tort "during the cause of employment"

Control Test:

Short V Henderson- Lord Thankerton identified what would show that the employer had control over the worker therefore being an employee:

1. Power to select a worker
2. Right to control the method of working
3. Right to suspend and dismiss
4. Payment of wages

Mersey Docks V Coggins and Griffiths- A person is more likely to be an employee if the employer had control over how they do their work, what they do.

McArdle J V Mitchell and Booker- The control test concerns "the nature and degree of detailed control".

Yewens V Noakes- The test was whether the employer had the right to control what the employee did and the way it was done.

Integration Test:

Harrison V McDonald and Evans-

1. A worker will be an employee if their work is fully integrated into the business;
2. If the person is an accessory to the business, that person is not an employee.
