Gup, 2012-12-06 Historians of our financial system will record this as an age of deregulation and bank mergers Deregulation a cornerstone of President Reagan's Administration resulted in federal and state legislation that contributed to increased competition for financial services and increased merger activity During the 1981-1986 period there were 2,139 mergers in banking and finance accounting for 16 percent of total merger activity More mergers occurred in banking and finance than in any other industry Because of these bank mergers there are vast amounts of data available for scholarly research This book presents some results of that research which will be of interest to academics bankers investors legislators and regulators The book consists of ten articles and it is divided into three parts Part 1 National and Regional Bank Mergers gives a broad perspective of merger activity The first article by Peter S.
