



# Marriage Contract

This Marriage Contract (the "Agreement") is entered into by and between John Doe, currently residing at Mignow (City), Slayou (State), and Joan Doe, currently residing at Mignow (City), Slayou (State) (the "Partners"), in anticipation of their marriage on 08.01.2024

**PROPERTY.** Any property owned by that Partner before the marriage, any property purchased with separate funds, any property inherited or received as a gift during the marriage defined as separate property. Each Partner will retain all of his or her separate property. Marital property - all other property acquired during the marriage. Marital property will be divided equally between the Partners in the event of divorce or legal separation.

**SPOUSAL SUPPORT.** In the event of divorce or legal separation, neither Partner shall be required to pay spousal support or alimony to the other Partner. If during marriage spouses have children, the Partner will pay support or alimony to the other Partner who will take care of children.

**RETIREMENT ACCOUNTS.** Each Partner will maintain ownership of his or her own retirement account. Partners will be solely responsible for any penalties, taxes or other obligations associated with those accounts.

**DEBTS.** Any debts incurred jointly by the Partners during the marriage will be divided equally between the Partners in the event of divorce or legal separation. Any debts incurred in his or her own name during the marriage and any debts that he or she incurred before the marriage are under the personal responsibility of each partner.

**DEATH.** In the event of the death of one Partner, the surviving Partner will inherit 25% share of deceased Partner's separate property, and will receive all of the of any marital property.

This Agreement shall be governed by and construed in accordance with the laws of the State of Slayou.
