## Introduction to migration studies (22/11)

- *Modes of Immigration Politics in Liberal Democratic States* (*The International Migration Review*, Gary P. Freeman)
  - three models of immigration politics
    - **settler societies**: periodically open immigration, machineries of regulation, dense webs of interest groups
    - countries receiving mass migration **since WWII**: negative outlook
    - countries receiving migration **since recently**: crisis condition, intensifying coordination of politics within the EU

## Crossed mobilities within a context of crisis (27/11)

- in the era of globalization, mobility is not only a new **lifestyle** but also an element in **social life** → the internet allows us to move even when seated
- **geographical mobility**: physical movement of things or people from one spatial point to another (migration or transport studies)
- social mobility: movement made by people between **social positions**
- new **concepts**: digital nomads, compressed space, traveling cultures, deterritorialization, hybridity
- *Regimes of Mobility across the Globe* (*Journal of Ethnic and Migration Studies*, Nina Glick Schiller)
  - **mobility studies**: developed in a period where movement of capital and labor were celebrated, first looking at every type of "traveller" through one lens and then making a distinction
    - **methodological nationalism**: approach to mobility studies that analyzes international movements as if they were internal to one nation-state
    - should normalise mobility but not minimize the ways in which legal status and ethnicity can make a **difference** in terms of ease of travel, repercussions, and gain or loss of status from being from elsewhere
  - **normalisation of mobility and stasis**
    - **anti-globalisation** studies scholars argue that speaking about "**flows**" of people, capital and ideas makes these phenomena seem like new concepts
    - new "mobility studies" place too much emphasis on "**elite travelers**" and their "liberating" travels, forgetting about other categories → question of **class consciousness**
  - sidelined migration types
