of direct or indirect loss resulting from inadequate or failed internal processes people and systems or from external events BCBS 2001 2 This definition includes also the legal risk but not the reputation risk and strategic risk A lot of industry representatives applied this definition hence it can now be assumed as the standard one According to this definition the operational risk can be divided into two main streams of risk the external and the internal risk The internal risk arises inside the institution whereas the external risk arises outside the institution
