toward acknowledging the interests of racial minorities though this approach was halting and reluctant at times Unlike many southern politicians who emerged as reactionary figures during the civil rights era Hollings adapted to the changing racial politics of the 1960s while pursuing a clear course Vietnam War hawk fiscal conservative regional economic booster and free trade opponent While Hollings was at times an atypical southern senator his behavior in the 1960s and 1970s served as a model for survival as a southern Democrat His approach to voting rights military spending and social and cultural issues was mirrored by many southern Democrats between the 1970s and 1990s Hollings s career demonstrated an alternative to hard edged political conservatism one that was conspicuously successful throughout his Senate tenure
