### Management Commitment and Employee Participation

- Create and implement a policy to communicate the conduct expected of patients, employees, visitors, and other third parties.

### Safety and Health Training

- Train workers to inform them on how to recognize hazards and protect themselves and others.



### Worksite Analysis and Hazard Identification

- Identify risks and hazards and review safety records.



### Hazard Prevention and Control

- Utilize engineering controls and administrative and work practice controls to mitigate risks and hazards.



### Recordkeeping and Program Evaluation

- Accurate recordkeeping can help employers determine the extent of the workplace violence issue and evaluate trends, patterns, and methods of hazard control.

Occupational Safety and Health Administration,1996      [Guidelines for Preventing Workplace Violence for Health Care & Social Service Workers](#) U.S. Department of Labor,Occupational Safety and Health Administration,2014-03-12 The National Institute for Occupational Safety and Health NIOSH defines workplace violence as violent acts including physical assaults and threats of assaults directed toward persons at work or on duty This includes terrorism as illustrated by the terrorist acts of September 11 2001 that resulted in the deaths of 2 886 workers in New York Virginia and Pennsylvania Although these guidelines do not address terrorism specifically this type of violence remains a threat to U S workplaces For many years health care and social service workers have faced a significant risk of job related violence Assaults represent a serious safety and health hazard within these industries OSHA s violence prevention guidelines provide the agency s recommendations for reducing workplace violence developed following a careful review of workplace violence studies public and private violence prevention programs and input from stakeholders OSHA encourages employers to establish violence prevention programs and to track their progress in reducing work related assaults Although not every incident can be prevented many can and the severity of injuries sustained by employees can be reduced Adopting practical measures such as those outlined here can significantly reduce this serious threat to worker safety In January 1989 OSHA published voluntary generic safety and health program management guidelines for all employers to use as a foundation for their safety and health programs which can include workplace violence prevention programs OSHA s violence prevention guidelines build on these generic guidelines by identifying common risk factors and describing some feasible solutions Although not exhaustive the workplace violence guidelines include policy recommendations and practical corrective methods to help prevent and mitigate the effects of workplace violence The goal is to eliminate or reduce worker exposure to conditions that lead to death or injury from violence by implementing effective security devices and administrative work practices among other control measures The guidelines cover a broad spectrum of workers who provide health care and social services in psychiatric facilities hospital emergency departments community mental health clinics drug abuse treatment clinics pharmacies community care facilities and long term care facilities They include physicians registered nurses pharmacists nurse practitioners physicians assistants nurses aides therapists technicians public health nurses home health care workers social workers welfare workers and emergency medical care personnel The guidelines may also be useful in reducing risks for ancillary personnel such as maintenance dietary clerical and security staff in the health care and social service industries      *Workplace Violence* Abigail Marie Sweet,2017 Workplace violence is a major issue in many occupations Acts of workplace violence can cost companies millions of dollars Using a workplace violence prevention programs to control workplace violence could be vital in saving a company money and possibly saving someone s life There are four types of workplace violence that could occur criminal

intent customer client employee on employee and personal relations The purpose of this study was to describe and explore workplace violence incidents and describe their contents utilizing the United States Occupational Safety and Health Administration s Integrated Management Information System IMIS database in order to investigate the adequacy of the OSHA IMIS database to provide sufficient information in support of developing workplace violence prevention programs OSHA is responsible for inspecting and describing catastrophic and fatal acts of workplace violence Inspection data was reviewed and analyzed for the purpose of this study The data showed that OSHA inspected fatalities with much more urgency than they inspected injuries and nonfatalities Forty four out of the fifty workplace violence fatalities that were analyzed were inspected by OSHA within seven days of the fatality occurring or 88 percent Twenty three out of fifty workplace violence nonfatalities and injuries were inspected within nine days of the incident occurring only 46 percent This leads to the conclusion that OSHA takes workplace violence fatalities much more seriously and there is not as much of a sense of urgency when it comes to workplace violence nonfatalities and injuries A person being shot with a gun was the number one cause of workplace violence fatalities among the 100 incidents investigated This accounted for sixty eight percent of all workplace violence fatalities included in this research Security measures should be implemented in highrisk occupations such as bulletproof screens protecting the employees or providing security officers to protect the employees These high risk occupations include taxi drivers and late night convenience store workers The data collected for the purpose of this research identified many inconsistencies and missing data within the 100 workplace violence event descriptions found on the IMIS database This makes describing the data fully and drawing conclusions very difficult OSHA inspectors should consider a more uniform approach when collecting variables at a particular scene which would lend to a deeper understanding of workplace violence and potentially a more robust workplace violence program This lack of information was a limitation in the research conducted Workplace violence is a serious issue that countless employers and employees must deal with every day There must be programs set in place such as the one California has implemented and is having so much success with in order to bring awareness to employees and employers about how to handle workplace violence and to teach them what to do in situations that could otherwise be harmful to them OSHA must do a better job in describing the scenarios that they encounter in order to set up policies and procedures that are more comprehensive which could be beneficial to the next company that may face workplace violence in setting up a workplace violence program **Occupational Health Guide to Violence in the Workplace** Thomas D. ### **Experts' Consensus of Osha's Guidelines for Workplace Violence Prevention Program**

**Effectiveness** Javier Berezdivin,2008 The purpose of this research was to investigate if a panel of workplace violence WPV experts were of the same opinion that the five recommended OSHA guidelines were effective elements to use in a WPV prevention program Second the researcher sought to develop a comprehensive list of elements for an effective WPV program and to explore the experts' opinions as to the ranked importance and feasibility of the identified elements Finally the study compared the list of elements developed from this study with the five OSHA guidelines A two round online Delphi instrument was used to survey a panel of 27 experts in the field of WPV prevention the experts invited to participate were chosen as a result of their professional experience publications conference presentations and personal recommendations the first round yielded general opinions as to how experts defined WPV program effectiveness how they measured a program's effectiveness and their opinion on the effectiveness of the current five OSHA guidelines for WPV prevention in both retail sales establishments and healthcare settings the responses generated in the first round helped in the construction of the second round by providing a list of elements used in WPV prevention programs the second round asked experts to rate 76 elements in seven distinct categories of violence prevention strategies on a 5 point Likert scale the results provided substantial consensus for the effectiveness of the five OSHA guidelines and generated a comprehensive list of 76 elements to be considered when establishing an effective WPV program Experts expressed strong agreement on the importance of 75 of the elements and expressed a weak level of agreement on the importance of only one element peer support programs Regarding the feasibility of the elements experts expressed a weak level of agreement on only two elements outplacement services for terminated employees and the training of other individuals outside an organization such as clients patients and or customers It is recommended that empirically driven research be conducted on an ongoing basis in a wide variety of industry sectors to lend further support for the effectiveness of each of these elements
