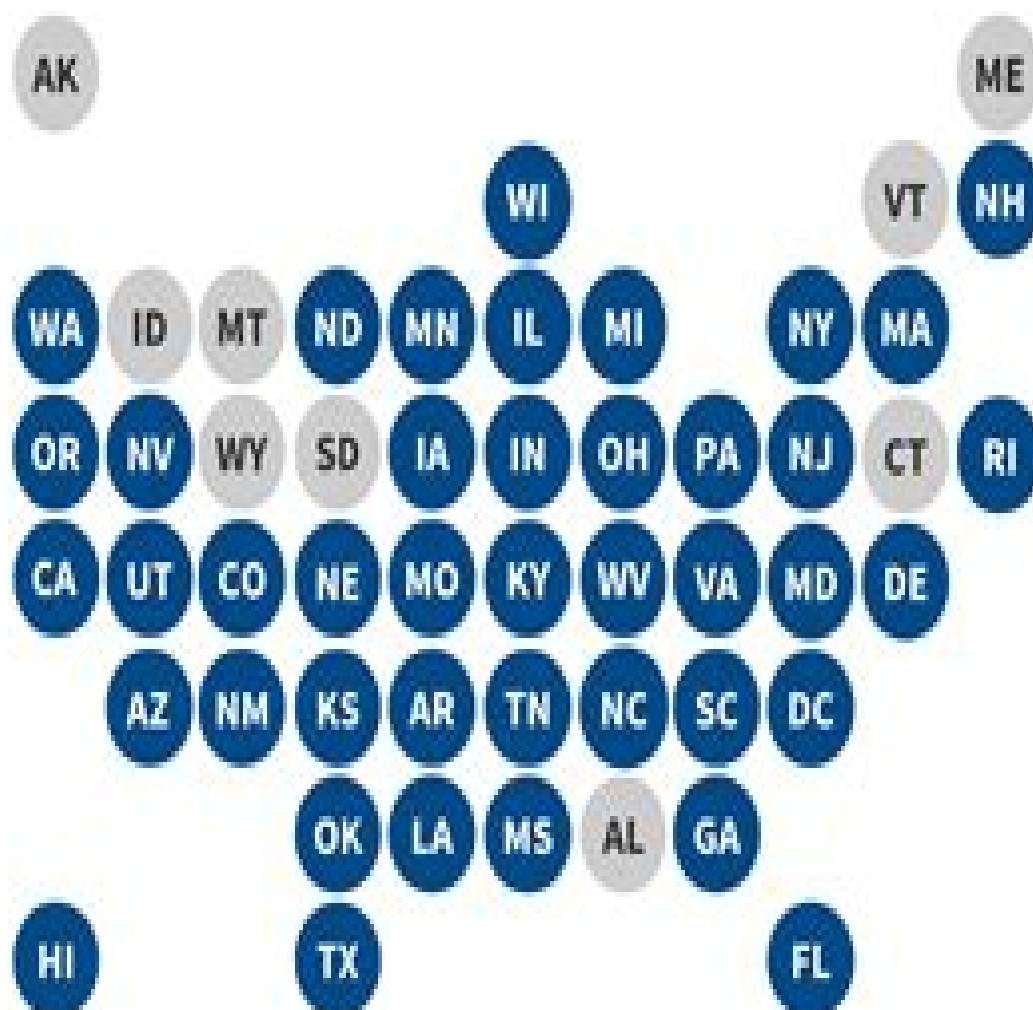


Most States Contract with Comprehensive Medicaid Managed Care Plans
